RECEIVER'S UNOPPOSED MOTION TO MODIFY ORDER APPOINTING RECEIVER

TO THE HONORABLE JORGE A. SOLIS, UNITED STATES DISTRICT COURT JUDGE:

COMES NOW, Michael J. Quilling, in his capacity as Receiver ("Receiver"), and files this his Unopposed Motion to Modify Order Appointing Receiver, and in support of such would respectfully show unto the Court as follows:

1. On November 17, 2006, the United States Securities and Exchange Commission filed its Complaint thereby initiating these proceedings and, in connection therewith, sought the appointment of a receiver. On that same day, and with the agreement of all of the parties, the Court entered its Order Appointing Receiver ("Order") pursuant to which Michael J. Quilling was appointed as receiver. By virtue of that Order, the Receiver was authorized to have RECEIVER'S UNOPPOSED MOTION TO MODIFY

complete and exclusive control, possession, and custody of all Receivership Assets. The Receiver has been acting and fulfilling his duties since his appointment.

- 2. Subsequent to his appointment, the Receiver has made a preliminary review of the books and records of ABC Viaticals, Inc. ("ABC Viaticals") and met with its employees. In addition, the Receiver has met with the Trustee for the numerous trusts that hold the life

- 3. ABC Viaticals, as Grantor, created numerous trusts established to hold the beneficial interest in life insurance policies on behalf of the investors (collectively referred to as the "Trusts"). Attached hereto as Exhibit "A" is a list of all trusts created by or for the benefit of ABC Viaticals. Upon information and belief, all of the Trusts are "revocable" at the sole discretion of ABC Viaticals, the Grantor. As investors sent their money to ABC Viaticals, they would be "matched" to a life insurance policy, wherein, they would be designated as a beneficiary of the trust holding that policy. Ideally, once the policy matured the death benefits would be paid to the trust and the Trustee would forward to the investor their respective share.
- 4. While the Order Appointing Receiver authorizes the Receiver to take control and possession of all Receivership Assets, including but not limited to trusts owned or controlled by ABC Viaticals, based on past experience, the Receiver anticipates that one or more of the insurance companies involved will claim the Order is not specific enough to suit them. In order to more effectively interact and negotiate with third-parties, namely the insurance companies that wrote the life insurance policies, it is the Receiver's request that the Order be clarified or modified to expressly include the Trusts. Clarification of the Order will enable the Receiver to effectively and properly conduct his duties and obligations.

5. The Trusts are the direct beneficiaries of the life insurance policies, which represent the most valuable assets of ABC Viaticals. Clarification of the Order will enable the Receiver to efficiently administer these valuable assets.

WHEREFORE, PREMISES CONSIDERED, Michael J. Quilling, Receiver, requests this

Court to issue an order to clarify or modify the Order Appointing Receiver to specifically include
