STIPULATION FOR ORDER GRANTING EXTENSION OF TIME TO RESPOND TO MOTION FOR SHOW CAUSE HEARING AND REQUEST FOR EXPEDITED HEARING

§

This Stipulation is entered into by and between MICHAEL J. QUILLING, Receiver of ABC Viaticals, Inc., Movant for a Show Cause Hearing, and Donald S. Kaplan, Respondent thereto, to extend the time in which Donald S. Kaplan may respond to the Receiver's Motion for Show Cause Hearing and for other relief. In support of the Stipulation, the parties state as follows:

1. On November 17, 2006, the Securities and Exchange Commission filed this instant action, and sought the appointment of a receiver for the assets of ABC Viaticals, Inc. The

Court granted the motion of the Securities and Exchange Commission, and appointed Michael Ouilling as receiver.

- 2. On April 5, 2007, Quilling, as receiver, filed a motion with the Court for a Show Cause Hearing so as to command Kaplan to return transfers which the receiver alleges are fraudulent transfers under the Uniform Fraudulent Transfer Act as enacted in the various states ("Motion"). The Motion was served by mail upon Kaplan.
- On May 11, 2007, the Court entered a prior stipulated order [Dkt. No. 50] 3. granting Kaplan an extension until June 1, 2007 to respond to the Motion in order to locate and retain local counsel and for Kaplan's California counsel to be admitted as a member of the Bar of this District Court pro hac vice.
- Kaplan has subsequently located local counsel and his California counsel, Richard 4. Baum, has submitted an application to the court to be admitted pro hac vice. Counsel for Kaplan seeks a short extension in order to allow Mr. Baum to be admitted pro hac vice and to allow local counsel an opportunity to familiarize themselves with the procedural history, facts, and law necessary to respond to the Motion.
- 5. Nothing contained in this Stipulation is intended to be, nor should be construed as, the submission by Kaplan to the personal jurisdiction of this Court over him.
- NOW, THEREFORE, IT IS HEREBY STIPULATED by and between MICHAEL J. QUILLING, Receiver of ABC Viaticals, Inc. and Donald S. Kaplan that the time for Kaplan to respond to the Motion for Show Cause Hearing shall be extended for a period of fourteen (14) days, until June 15, 2007.
