AGREED ORDER FOR INSPECTION OF RECEIVERSHIP RECORDS

Quilling, as Receiver for ABC Viaticals, Inc. and related entities ("Plaintiff" or "Receiver"), and submits this Agreed Order for Inspection of Receivership Records requested by Respondent Donald S. Kaplan ("Respondent"). The Receiver would respectfully show the Court as follows:

- 1. Respondent has served written discovery upon the Receiver requesting, among other things, corporate records of ABC Viaticals, Inc. and the ABC Investor Trusts (collectively, "ABC') that contain personal and financial information relating to ABC's investors. The Receiver has agreed to make those records available subject to this protective order.

that contain personal and financial information of its investors. Respondent, his counsel, and his designated expert (a) shall not disseminate, publish, or otherwise share that information with other parties without the Receiver's prior approval and (b) shall not submit those records as an exhibit or other attachment in this case without first redacting all of the investor's, beneficiary's, and spouse's personal and financial information including, but not limited to, their names signatures, social security numbers, dates of birth, addresses, telephone numbers, fax numbers, and e-mail addresses. Dates, investment amounts, investor's initials, insurance policy numbers, and investment identification numbers need not be redacted.
