AGREED SCHEDULING ORDER EXPANDING EXPERT DEADLINES

Now before the Court is Plaintiff Michael J. Quilling's Motion to Approve Agreed Scheduling Order Expanding Expert Deadlines. After reviewing that motion and considering its agreed nature, the Court finds that it should be GRANTED.

IT IS ORDERED that, by agreement of the parties, the Court modifies its scheduling order [Dkt. No. 54] as follows:

1. Christopher R. Erwin will be deposed in Dallas, both individually and as a representative of Erwin & Johnson LLP, after the Court rules on the Defendants' pending Motion for Leave [Dkt. No. 62].

2. If that motion is denied in whole, Defendants' will produce Erwin for deposition within 21 days after entry of that order.

3. If that motion is granted, in whole or in part, Defendants' will produce Erwin for deposition within 45 days after entry of that order.

4. The Receiver shall have 30 days after Erwin's deposition to designate his experts and produce expert reports.

5. Defendants shall have 30 days after the Receiver's designations to designate their experts and produce expert reports.

6. Third-Party Defendant shall have 30 days after the Defendants' designations to designate its experts and produce expert reports.

7. All other deadlines in the current scheduling order shall remain unchanged.
