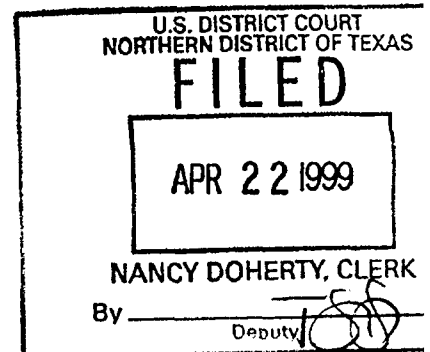

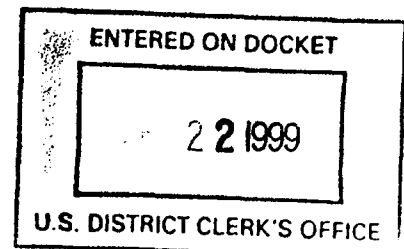

ORDER FOR B. DAVID GILLILAND, HAMMERSMITH TRUST, L.L.C.  
AND HAMMERSMITH TRUST, LTD.  
TO APPEAR AND SHOW CAUSE

This Matter is before the court based upon the Motion of Michael J. Quilling, the court appointed receiver herein (the "Receiver") requesting the court to Order B. David Gilliland, Hammersmith Trust, L.L.C. and Hammersmith Trust, Ltd., each who have appeared before this court, to appear before the court and show cause, if any there be, why they should not be sanctioned, and/or held in contempt for violating the terms of the Agreed Order Modifying and Abating Orders of January 21, 1999, and March 11, 1999, Freezing Assets and Appointing Temporary Receiver, entered on March 26, 1999 (the "Abatement Order"), by this Court.

The Court, having reviewed the Receiver's motion, together with the Declaration in Support of Motion for Show Cause Order, filed concurrently therewith is of the opinion that a hearing on the Receiver's allegations is warranted. It is accordingly ORDERED,

that B. David Gilliland, Hammersmith Trust, L.L.C. and Hammersmith Trust, Ltd. to, appear in person before this court, on the 3<sup>rd</sup> day of May, 1999, at 2:00 o'clock P.m., then and there, to show cause, if any there be, why ~~she~~<sup>they</sup> should not be held in contempt, and/or have sanctions entered against ~~her~~<sup>them</sup>, for violating the terms of the Abatement Order.
