**AGREED ORDER**

On this day came on for consideration the Receiver's Motion to Compel Reconveyance of Receivership Property, Payment of Rent and Vacation of Property by Strong Heart, Inc., and the Court's February 12, 2001 Show Cause Order as to Strong Heart, Inc., at which time the parties announced to the Court that a settlement had been reached as to the matters in dispute, which settlement the parties requested be documented by virtue of an Agreed Order. In accordance with the settlement reached,

IT IS ORDERED that Strong Heart, Inc. shall, on or before March 1, 2001, execute and

deliver to Howe Financial Trust a Warranty Deed to the property having a street address of 58100 Pottawatamie, Osceola, Indiana ("Property").

IT IS FURTHER ORDERED that Strong Heart, Inc. and all persons or entities currently occupying any portion of the Property shall vacate it by 10:00 p.m. on Sunday, March 4, 2001 and thereafter surrender possession of the Property to the Receiver.

IT IS FURTHER ORDERED that Strong Heart, Inc. shall, if not done so already, provide a complete list of all utility providers and account numbers with respect to the Property to the Receiver on or before noon on February 27, 2001.

IT IS FURTHER ORDERED that Strong Heart, Inc. shall execute such other documents as may be reasonably requested by the Receiver so as to properly effect a conveyance of the Property and the intent of this Order.
