At the time the Court approved the enclosed Claim Form, the Court also established March 31, 2001 as the deadline by which you must complete and return the Claim Form to me. Failure to

return the Claim Form by the deadline may result in your payment being delayed and/or your claim being disallowed. **BE SURE TO COMPLY WITH THE DEADLINE**.

Ibelieve the Claim Form is self-explanatory, but if you have questions, you may call my legal assistant, Steve Tomasky at (214) 880-1812. Because of the number of people involved, it may take several days for him to return your call. When I receive your completed Claim Form I will send you a post card acknowledging my receipt of your Claim Form. If you do not receive a post card from my office within ten (10) days after you send your completed Claim Form to me please contact Steve Tomasky at my office. After my office has an opportunity to review your completed Claim Form, we will contact you if we have any problems with your claim. There is no need for you to contact us, we will contact you.
