1. On May 22, 2003, the Court issued an Order appointing the Receiver. Thereafter, on October 2, 2003, the Receiver filed a Motion to Establish Claim Procedures and Approve Claim Form, which the Court granted by Order dated November 24, 2003.

2. Subsequent to the entry of the Order regarding the claim form, the Receiver distributed the claim form to potential claimants. The Receiver has begun a final review of the claims and has identified the claims, which are now ready to be submitted to the Court for approval.

3. Specifically, attached hereto as Exhibit “1” is a list of claimants who have filed claims with the Receiver that the Receiver believes should be allowed in the amounts set forth in the net

claim column. As set forth in Exhibit "1", there are 210 claims in the total allowed amount of \$10,409,979.68.

4. The Receiver requests that upon final consideration of this motion the Court allow each of the claims set forth in Exhibit "1" hereto as claims in these proceedings.

5. The Receiver is continuing to process other claims that have been submitted to him and hopes to be in a position to file a final motion regarding allowance of claims in the very near future.

WHEREFORE, premises considered, the Receiver requests that upon final consideration of this Motion the Court approve the claims as requested and for such other and further relief, general or special, at law or in equity, to which the Receiver may show himself justly entitled.
