**STATUS REPORT**

Defendant / Counterclaimant / Cross-Claimant Rein Evans & Sestanovich, L.L.P. (“Rein Evans”) hereby provides the following status report in accordance with the Court’s September 5, 2006 order.

The Plaintiff has reached an oral settlement of the case with defendants Rein Evans, Melrose Escrow and Paul J. Cohen. Counsel for Rein Evans is in the process of drafting the settlement agreement and anticipates that the Plaintiff will seek court approval for the settlement. Counsel for Rein Evans has spoken with the Plaintiff and with counsel for Melrose Escrow who requested that this status report be filed jointly on their behalf.

Defendants Grand Street Trust, Heartland Control Trust, Future Control Trust and Marie Margarite Gueco Mercado Paquette (the “Paquette Defendants”) are in default with respect to the counterclaims asserted by Rein Evans. An order for entry of default

was entered against them on October 19, 2005. Rein Evans intends to file a motion seeking the the entry of a default judgment against the Paquette Defendants.

The Receiver intends to move for entry of default against the Paquette Defendants because no answer has been filed since the motion to dismiss was denied.
