

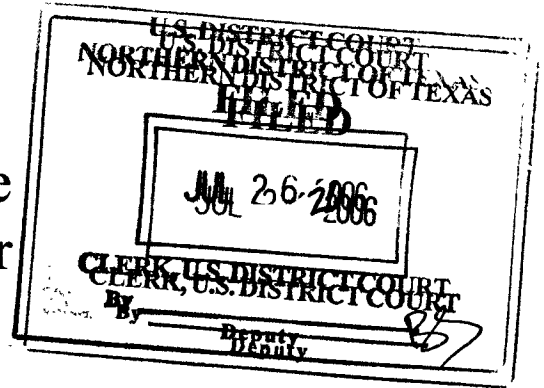

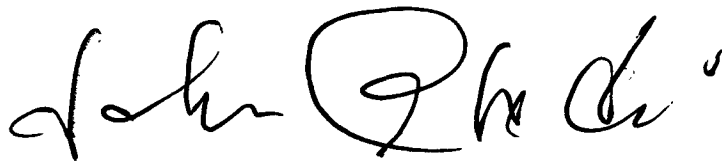

In March Of 2005 I answered to a solicitation in the Oxford Club News letter. It was from a Mr. Bob Reese 316 Mid Valley Ctr. #159 Carmel, Ca. Tele 831 626-7778. I called him and he was pushing viaticals from a company called ABC viaticals located in Texas. I did a background check on this company and they were thrown out of states and principles were tainted. I relayed this to Bob Reese and he turned me on to a Gary Lancaster, president of lancorp financial fund, located, 1382 Leigh Court, West Linn, Oregon 97068.

I contacted Mr. Lancaster and he stated he was involved in a Company that did Forward Commitments with Corporate Bonds. Our Principal was always safe and fluxation would be dividend interest. I asked him questions concerning this practice and he stated he did it before. He stated that the market was hot overseas. I called his bank and verified his background. Also his brother was vice president Larry Lancaster and he had held political office so it appeared to be a bonafide offer

Well Mr. Gary Lancaster forwarded the offering to me and I sent a total of \$390,000.00 In March 2005 I sent \$200,000.00 and April 2005 I sent \$190,000.00 this was my life savings. This money was 3 generations of savings. I am totally disabled and receive \$1100.00 per from SS disability.

In June of 2005 I received a check for \$4595.00 I called Gary Lancaster and stated why was it so low? Mr.. Reese told me they were averaging 12 to 15 per cent dividends. Mr. Lancaster stated he was waiting for funds to clear and I would receive extra pay out in October 2005. He paid dividends every three months. I did a google search and there was an article that Gary Lancaster was a victim of fraud for 9.3 million dollars. I called him and he stated don't believe everything you read and my money was safe. I even called his brother Larry and he stated the same thing. At this point I requested my money back and received an email that I would have it back October 2005. I did not hear from him again until Sept. Oct. and he called me and stated that the money invested went to a fraudulent company and he was doing his best to get money released from SEC. I reported the incident to SEC and they stated Mr. Lancaster made a fraudulent offering

Needless to say the SEC has frozen Mr. Lancaster assets pertaining to the Lancorp Financial Fund Group.

The money went to a company called Mega Fund owned by a Stantley Leitner. Leitner sent it to SARDAUKER HOLDING IIBC OWNED BY Bradley Stark who was on probation at the time of the scam for selling phony treasury bonds. Bradley Stark should be indicted and bail should be quite high. He is a threat to flee. His lawyer has removed himself from the case. Stark is a real piece of shit. He is representing himself now.

A James Rump is also received money from this scam. SEC is also investigating him.

My complaint is with all 4 scammers. Gary Lancaster who sent out a fraudulent offering and loss everybody's money. I call him the pied piper. His scam was to make believe he was working hard making Forward commitments transactions but what he really did was forward all the money to Mega Fund and he figured he would get a piece of our money for doing nothing. He circumvented the broker dealer requirement. He also calls himself and a financial adviser. This is not true. He is licensed life insurance agent in Oregon.

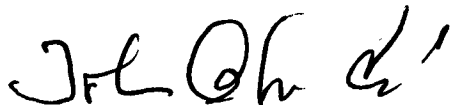
