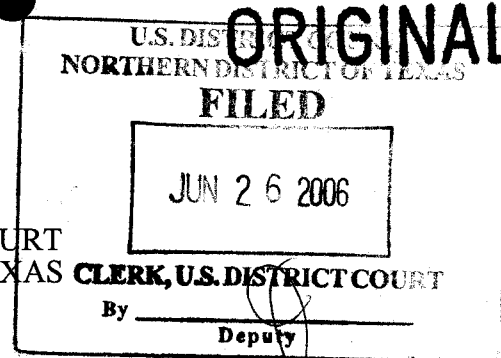

The undersigned, Marc K. Sellers, a member of the Oregon State Bar, hereby moves to withdraw as counsel for Lancorp Corp.

The reasons for this motion are as follows:

I have never entered an appearance in this action on behalf of Lancorp, or any other party, save and except only having signed an "Agreed Motion to Expand Receivership" on or about January 17, 2006. That Agreed Motion was prepared and presented by Michael Quilling, the Receiver in this case. At that time, as I was representing Lancorp in the state of Oregon, and as the Receiver represented that the signing of that Agreed Motion was an appropriate fashion in which to approach this matter from the standpoint of the Receivership, at the instruction of my client, Lancorp, I signed that document and returned it to Michael Quilling.

I am not a member of the Texas State Bar; nor have I been admitted to practice in the United States District Court for the Northern District of Texas. I have not appeared on behalf of Lancorp in this action on any occasion. Shortly after signing the Agreed Motion to Expand Receivership, I and my firm terminated our attorney/client relationship with Lancorp, and closed our file on this matter.

I have not communicated with Lancorp since the date of termination of the attorney/client relationship and am not aware of the current status of these proceedings, or Lancorp's involvement therein.

I recently became aware of the fact that I have been listed as counsel for Lancorp in a webpage apparently maintained by the Receivership. Additionally, I have recently received from the Court a directive to all attorneys of record. At that point I became aware of the fact that I have apparently been listed as an attorney of record in this case.

For the foregoing reasons, I respectfully request that, to the extent that I am listed as counsel of record for any party in this proceeding, I be allowed to withdraw therefrom.
