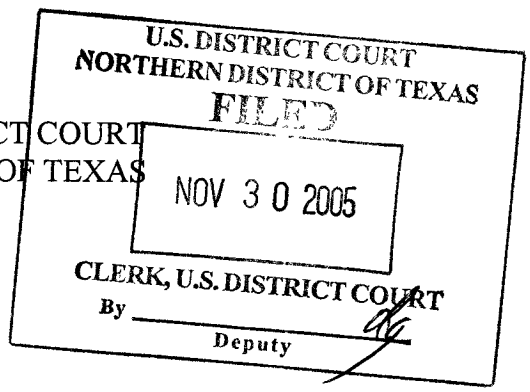

FREE AND CLEAR OF ALL LIENS, CLAIMS, AND ENCUMBRANCES**



Quilling, Receiver and to send the titles to his office address at: 2001 Bryan Street, Suite 1800, Dallas, Texas 75201.

IT IS FURTHER ORDERED that the Receiver is hereby authorized to sell the 2005 Jaguar (VIN #SAJWA03V451N15231), a 2005 BMW 745i (VIN #WBAGL63595DP76690), a 2005 BMW 745Li (VIN #WBAGN63515DS58518), a 2005 Audi S4 (VIN #WAUPL68E85A064763), a 2005 Volvo S40 (VIN #YV1MH682752070622), and a 2004 Cadillac XLR (VIN #1G6YV34A545600291) to Jeff Bayer of Dallas, Texas, free and clear of all liens, claims and encumbrances.

IT IS FURTHER ORDERED that the Receiver is authorized to take all steps necessary to consummate the transaction and to provide for its closing.
