TO THE HONORABLE JEFF A. KAPLAN, UNITED STATES MAGISTRATE JUDGE:

Pursuant to this Court’s Order of August 19, 2005 [Docket No. 53], the Receiver submits his First Motion to Allow “A” Claims.

1. As part of his duties, the Receiver has reviewed numerous claims submitted against the Lancorp Financial Receivership Estate. Attached hereto as Exhibit “1” is a list of “A” claims against the Lancorp Financial Receivership Estate which the Receiver has reviewed and to which he has no objection for the period ended October 16, 2006. Accordingly, the Receiver requests that the Court allow each of the 130 “A” claims set forth in Exhibit “1” totaling \$10,568,053.02 as investor claims against the Lancorp Financial Receivership Estate.

2. Consistent with this Court's Order of October 19, 2005, the Receiver requests that if no objection is filed within thirty (30) days after the date of filing this motion, the Court enter an order allowing the "A" claims listed on Exhibit "1".

3. **The Receiver is still in the process of reviewing other claims against the Lancorp Financial Receivership Estate. Those claims will be the subject of future motions. This motion does NOT address claims against either the Sardaukar Holdings Receivership Estate or the Megafund Receivership Estate.**
