**DECLARATION OF MICHAEL J. QUILLING, RECEIVER, IN SUPPORT OF
PLAINTIFF’S MOTION FOR SUMMARY JUDGMENT**

I, Michael J. Quilling, the Receiver in the above-captioned matter, do hereby declare under penalty of perjury and in accordance with 28 U.S.C. § 1746 that the following is true and correct, that this declaration is made of my personal knowledge, and that I am competent to testify as to the matters stated herein.

1. I am the duly appointed Receiver for Sardaukar Holdings IBC, Bradley C. Stark, and other related entities and individuals named as defendants in *Securities and Exchange Commission v. Megafund Corporation, et al.*, Cause No. 3:05-CV-1328-L (the “SEC Proceeding”), pending in the United States District Court for the Northern District of Texas.

2. On July 5, 2005 the Court entered its Order Appointing Receiver, which authorized me to investigate, collect, liquidate, and preserve assets of the Receivership Estate. That Order was amended on July 19, 2005 to include additional defendants.

3. In my capacity as Receiver, I have investigated virtually all aspects of the Sardaukar Holdings, IBC (“Sardaukar”) investment program. I have seized all known bank accounts, subpoenaed records, interviewed numerous principals and investors, and investigated the underlying transfers and purchases from the Receivership Estate’s assets. Through these efforts, I have acquired personal knowledge of Sardaukar’s operations as well as the funds transferred to or on behalf of Hans Tschebaum, Michael Tschebaum, and Palace Investments, Inc.

4. Pursuant to the Order Appointing Receiver, I initiated this ancillary case against Hans Tschebaum, Michael Tschebaum, and Palace Investments, Inc. to recover funds sent to those parties from Sardaukar as more than \$1,000,000.00 in cash plus a 2005 Maserati Quatraporte (“Maserati”) purchased for \$141,675.71.

5. Sardaukar’s account statements from JPMorgan Chase Bank, N.A. provide a record of each transaction underlying this suit. That account was Sardaukar’s primary account, where Stark deposited all known contributions from investors. The account statements, however, are voluminous so I directed an accountant to prepare a spreadsheet summary which is attached and incorporated for all purposes as Exhibit B-1. Those records confirm the following transfers of Receivership Estate funds:

6. The financial records, along with my investigations, show that these transfers ultimately benefitted the Defendants. First, the payments to Michael Tschebaum went to his personal brokerage account. Second, Hans Tschebaum, his counsel, and Brad Stark have all indicated that Hans Tschebaum controls and regularly possesses the Maserati. Although the purchase agreement lists Administrative Specialists as the vehicle's buyer, Michael Tschebaum signed those documents and listed himself as president of the company. Third, Palace Investments is an entity controlled by the Defendants and Michael Tschebaum acts as its director, registered agent, and account signatory. In addition, Defendants themselves admit receiving the first six payments substantially as described in the Complaint but insist they represent "commissions" earned from the Sardaukar investment program.¹

7. Sardaukar, however, never generated any investment revenue—it was simply a *Ponzi* scheme. A *Ponzi* scheme exists where a company's only real income is from the new contributions of investors. Sardaukar was an unlicensed investment broker created and controlled by Bradley C. Stark ("Stark"). Stark and his associates recruited investors by promising high-yield returns and had them send funds to Sardaukar's account at JPMorgan Chase Bank, N.A. As Sardaukar received those funds, however, Stark systematically diverted large amounts to benefit himself, his friends, and his family – including the Tschebaums. What principal remained after Stark's spending sprees and


handouts were commingled and used to pay “returns” to earlier investors. This kind of arrangement illustrates a classic *Ponzi* scheme.

8. Sardaukar’s bank records from JPMorgan Chase establish the existence of a *Ponzi* scheme. They show that: (1) investor funds constituted virtually all of Sardaukar’s revenue; (2) those funds were commingled and used for personal expenses rather than legitimate investments; and (3) any investment “returns” to earlier contributors were actually *Ponzi* payments from the commingled funds of later contributors. Through my investigations, interviews, and from admissions of Brad Stark and his counsel, I know that the list of Sardaukar investors includes not only individual contributors, but numerous entities like CIG, Ltd., CDB&B Investors, Inc., Clover Investment, LLC, International Consultants & Referrals, and Investment World, Inc. Their contributions were commingled the same as other investors and applied toward *Ponzi* payments and personal expenditures.

9. The Defendants have never disputed the existence of this *Ponzi* scheme and freely admit receiving these payments from Sardaukar. As illustrated above, those payments are easily traced to the contributions of Sardaukar investors and should be returned to the Receivership Estate.

I declare under penalty of perjury and in accordance with 28 U.S.C. § 1746 that the foregoing is true and correct.
