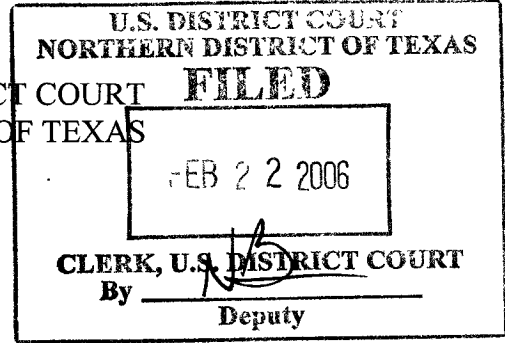

various and sundry other personal items of varying costs, including, *inter alia*, Rolex watches - and with more than a few trips to the ATM machine - rather than any sort of investment activities. Defendants attempt to classify these payments to them as “referral fees based upon profits earned in the accounts of the customers” they allegedly referred to the *Ponzi* scheme mastermind, Stark. There simply were no investment programs from which profits were earned.


3. As this Court’s duly appointed and qualified receiver, I have no interest in coercing a settlement of this matter with Defendants. My charter, as set by this Court, is to aggressively engage in the investigation and recovery of funds stolen from innocent investors in the fraudulent scheme perpetrated by Sardaukar and Stark. In this regard, having conclusively traced such investor funds directly into the hands of Defendants, my ultimate intent is to secure as close to a 100% recovery of such funds, and property purchased with such funds, from Defendants, limited only by the diminished value and/or amounts of such funds and property. In order to accomplish this, the funds and property need to be frozen by the Court now, preserving the *status quo* pending trial, in order to minimize their diminution in value.

4. The Stark and Hans Tschebaum affidavits, aside from referring to and attaching forged ManPro records, contain unabashed perjury. Sardaukar did not open “separate accounts for each investor” at ManPro as represented in their affidavits, and investor funds were, in fact, routinely co-mingled as clearly demonstrated by the Sardaukar account records attached to my original Declaration.

5. Defendants’ claims that the investor funds and Maserati are “their property” to which the Receiver “has no legal claim” are simply wrong. I have amply demonstrated that the funds and vehicle are directly traceable to pooled funds given to Sardaukar and Stark by investors in the scheme. According to applicable law, the assets are imposed with a constructive trust.

6. I declare under penalty of perjury and in accordance with 28 U.S.C. § 1746 that the foregoing is true and correct.

DECLARATION OF TONI ROSSETTI

I, Toni Rossetti, do hereby declare under penalty of perjury, in accordance with 28 U.S.C. § 1746, that the following is true and correct, and that I am competent to testify to the matters stated herein.

1. I am employed as a Compliance Manager in the Chicago office of Man Financial Inc (“Man Financial”). Man Financial is registered with the Commodity Futures Trading Commission as a licensed Futures Commission Merchant. I have been employed in this position since April of 2002.

2. As a result of my duties as Compliance Manager for Man Financial, I am familiar with the type, form, and substance of account statements generated by Man Financial and ManPro Futures.

3. I have reviewed the exhibits to the “Declaration of Bradley C. Stark In Support of Response of Defendants to Motion for Issuance of Preliminary Injunction”, a true and correct copy of which is attached hereto as Exhibit “A”. Exhibit A purports to be a series of “Daily Commodity Statements” for an account at ManPro Futures, a division of Man Financial, entitled SARDAUKAR HOLDINGS IBC (DIR) ***INTERNATIONAL CONSULTANTS AND REFRERALS INC.*** and having an account number of E G27 SARDKR 40118.

4. I have reviewed the documents contained in Exhibit A and determined that the account number for the account does not match the name on the account and that the account as styled in Exhibit A does not exist. Further, the documents attached hereto as Exhibit A were not generated by either Man Financial or ManPro Futures.


5. The only accounts at Man Financial in the name of or associated with Sardaukar Holdings IBC (“Sardaukar”), that I am aware of, were styled as Sardaukar Holdings IBC (E/S), account no. E G27 VANKR 40346 and Sardaukar Holdings IBC (DIR), account no. E G27 VANKR 40112 (collectively “the Sardaukar accounts”).

6. On July 7, 2005, and at the direction of Michael Quilling as receiver for Sardaukar Holdings, IBC and Bradley C. Stark, Man Financial closed account no. E G27 VANKR 40346 and sent the entire balance in the amount of \$323,629.79 to the Receiver. On July 8, 2005, Man Financial closed account no. E G27 VANKR 40112 and sent the entire balance in the amount of \$430,947.63 to the Receiver.

7. Other than account nos. E G27 VANKR 40346 and E G27 VANKR 40112, I am not aware of any other Sardaukar accounts. In addition, I am not aware of

any other accounts established by Sardaukar for the benefit of any investors or in which Sardaukar had a beneficial interest.
