On this day the Court considered the Receiver’s Motion to Compel Payment of Premium Share from James L. Kufeldt [BOT-M]. Having carefully considered the Motion and the pleadings and papers on file in this case, the Court is of the opinion, and so finds, that the Motion should be granted. Accordingly,

It is ORDERED that James L. Kufeldt shall, within 10 days of the date of this Order, pay the Receiver \$631.25 for his share of the premiums.

It is FURTHER ORDERED that James L. Kufeldt shall pay the Receiver his percentage share of all additional premium obligations within 10 days of the issuance of a written invoice.

It is FURTHER ORDERED that should James L. Kufeldt fail to pay \$631.25 for his share of the premiums or his percentage share of any additional premium obligations as they become due, James L. Kufeldt’s 0.47391% ownership and beneficial interest as well as James L. Kufeldt’s 0.94782% ownership and beneficial interest in the BOT-M Policy No. U10005943L will automatically be forfeited to the receivership estate and be replaced by an allowed claim for \$15,000.00 in his favor.
