OF PREMIUM SHARE FROM

A. REEVES [SWA-R&G]

On this day the Court considered the Receiver's Motion to Compel Payment of Premium Share from Michael G. Reeves and Judith A. Reeves [SWA-R&G]. Having carefully considered the Motion and the pleadings and papers on file in this case, the Court is of the opinion, and so finds, that the Motion should be granted. Accordingly,

It is ORDERED that Michael G. Reeves and Judith A. Reeves shall, within 10 days of the date of this Order, pay the Receiver \$774.49 for their share of the premiums.

It is FURTHER ORDERED that Michael G. Reeves and Judith A. Reeves shall pay the Receiver their percentage share of all additional premium obligations within 10 days of the issuance of a written invoice.

It is FURTHER ORDERED that should Michael G. Reeves and Judith A. Reeves fail to pay \$774.49 for their share of the premiums or their percentage share of any additional premium obligations as they become due, Michael G. Reeves and Judith A. Reeves's 1.125% ownership and beneficial interest in the SWA-R&G Policy No. A10164398L will automatically be forfeited to the receivership estate and be replaced by an allowed claim for \$10,000.00 in their favor.

1 It is FURTHER ORDERED that in the event Michael G. Reeves and Judith A. Reeves's
2 ownership and beneficial interest is forfeited to the receivership estate, then American General
3 Life Insurance Co. is ORDERED to change its records to reflect and effectuate the transfer.
